This Cornell-CRIMT workshop on June 26, 2019 in NYC is one in a series of regional workshops organized in the context of the CRIMT Partnership Project on Institutional Experimentation for Better Work in which Cornell is a Partner.

The purpose is to highlight on-going projects in organizational and institutional innovation in which the Cornell ILR School's Worker Institute has been engaged and to bring these projects into a broader discussion of experimentation in the regulation of work and employment.

The workshop will feature presentations of projects in four important areas: i) Addressing Sexual Harassment in the Workplace; ii) Community Economic Development; iii) Workers' Rights in the Gig Economy; and iv) Work, Labor and the Climate Crisis. The discussion will also extend to other important themes of common interest with a view to developing a data bank of cases of experimentation around which we can build a community of progressive scholarship to interrogate and learn from these cases and to make them available to a wider community of practice focused on making work better (and not worse).

For each of the themes, Worker Institute project leaders will present their cases of innovation. Partnership Project researchers from other CRIMT Partnership Project Partner Centres will respond in turn, drawing on their own cases, thus opening up the exchange to a more general discussion on what we can learn from cases of organizational and institutional experimentation.
